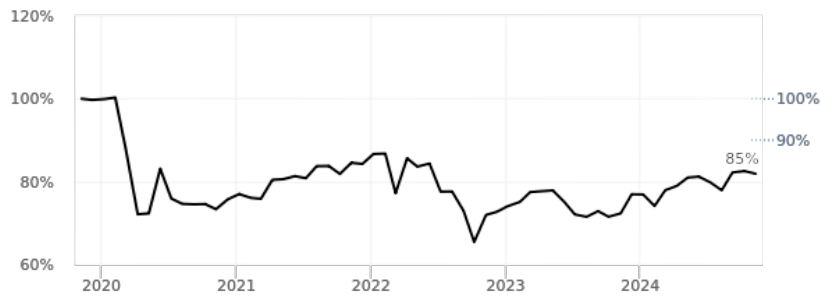

### Price underlying (% of the starting value)

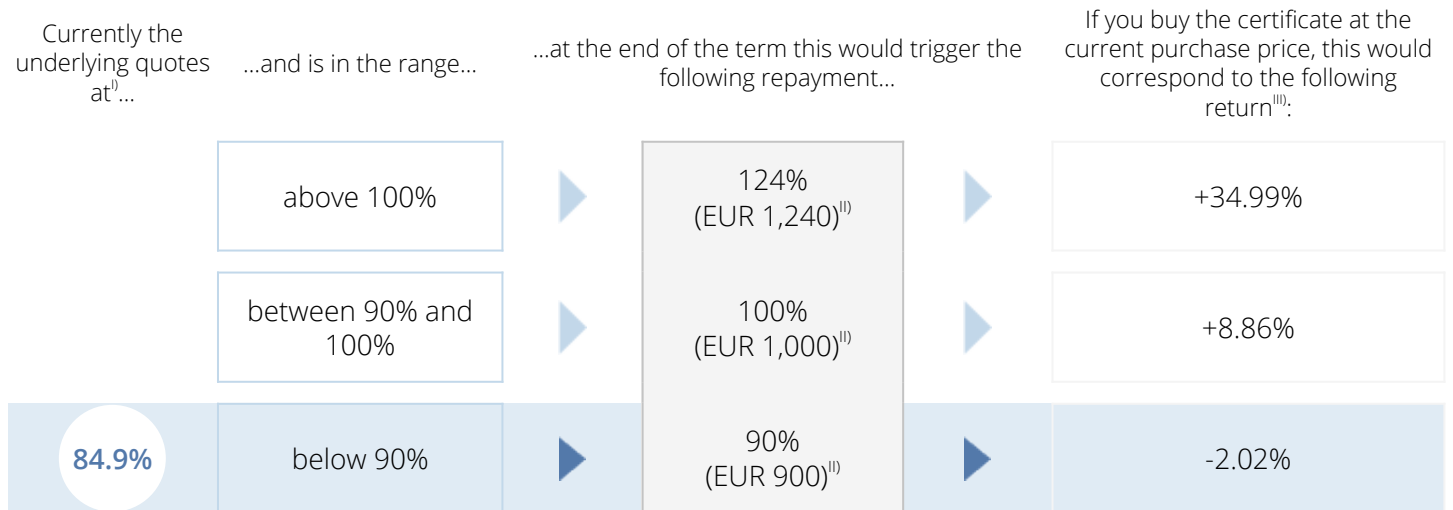

### The Underlying

**Select:** Stocks with low volatility and high dividend yields are selected.

Please note:
