

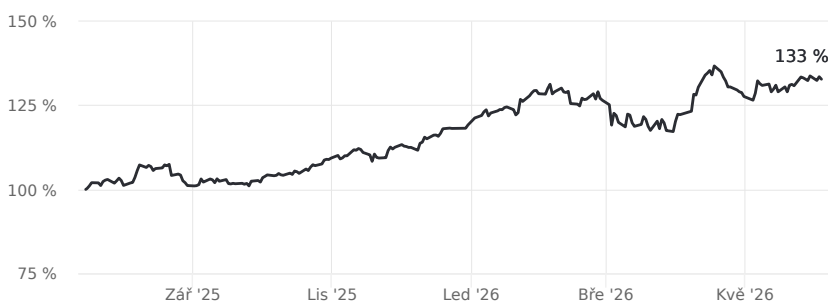

### Co byste měli zvážit před nákupem:
