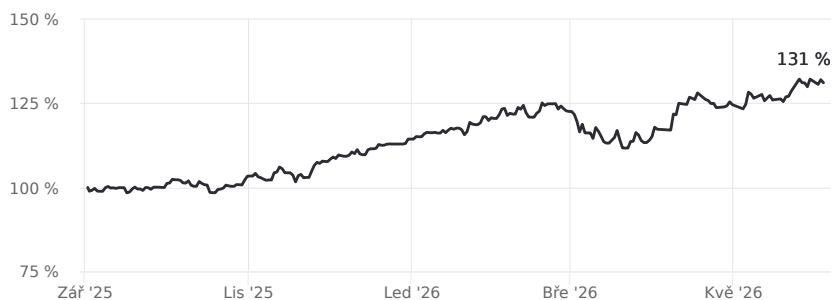
Popis

Co byste měli zvážit před nákupem:
