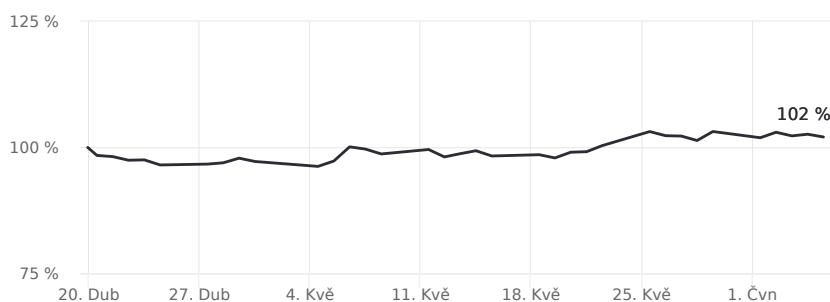
Popis

Co byste měli zvážit před nákupem:

- **Discount as a safety buffer:** If the negative performance of the underlying at the end of the term exceeds the discount, it results in a capital loss.
