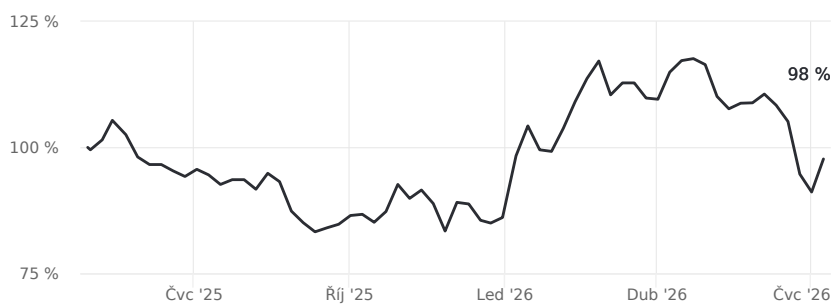
## Popis

### Co byste měli zvážit před nákupem:
