## Popis

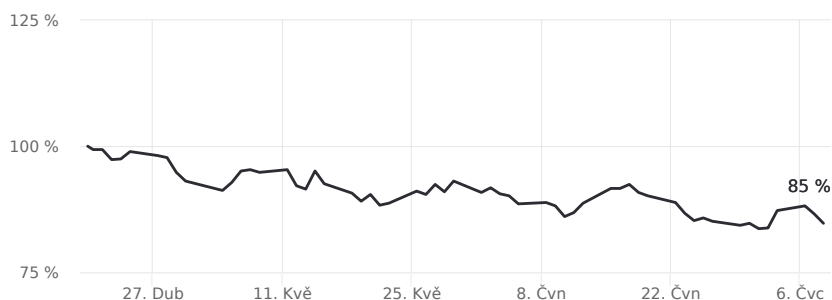
Discount Certificates are traded at a discount and quote below the current market price of the underlying. For this discount, the investor accepts to participate in price gains merely up to the cap.

### Co byste měli zvážit před nákupem:
