# **Functionality**

At the initial valuation date the starting value and at the final valuation date the final value of both underlying indices are determined. At the final valuation date the final value is compared to the starting value and one of the following scenarios will apply:

- 1. Final value of both indices ≥ 100% of the starting value → Redemption at 112% If the final value of both indices is greater or equal to 100% of the starting value, the certificate will be redeemed at the maturity date at 112% of the nominal value. This amount also represents the maximum redemption (maximum amount).
- 2. Final value of at least one of the two indices < 100% of the starting value → Redemption at 100%

If the final value of at least one of the two indices is below 100% of the starting value, the certificate will be redeemed at the maturity date at 100% of the nominal value.




