

FUNCTIONALITY

At the **initial valuation** date, the **initial value** of the underlying is determined and the **barrier** is defined on this basis. The underlying price is compared with the barrier during the observation period. At the final valuation date one of the following **scenarios** will apply:

1) Barrier not touched or undercut

If the underlying price was always above the barrier, 100% of the nominal value is paid out on the maturity date. This amount represents the maximum payout.

2) Barrier touched or undercut at least once

If the price of the underlying was at least once **at** or **below** the barrier, the payout on the maturity date is made in accordance with the performance of the underlying (percentage change from the starting value to the closing price at the final valuation date). The **interest rate** is composed of a **fixed** and a **variable component** and is paid out regardless of the performance of the underlying. The interest rate for the respective maturity year is determined as follows:

 percentage increase in the index is paid in addition to the fixed interest rate.
- DEFLATION: Level of euro zone HICP excl. tobacco is the same or lower than in the previous year: The annual fixed interest rate is paid out.




