Redemption at the end of term is affected at 100% if the underlying share (Wienerberger AG) quotes above the barrier at the end of term. If the share quotes below the barrier, it results in delivery of shares. In the event of a barrier violation at the end of term, investors are exposed to market risk on one-to-one basis; the value of the shares delivered will be significantly below the nominal amount of the Reverse Convertible Bond. Issuer Risk:

Reverse Convertible Bonds

What you should consider before the purchase:

- **Market risk:** The value of the Reverse Convertible Bond depends on the value of the underlying. Unfavourable developments of the underlying can therefore cause fluctuations in the value of the Reverse Convertible Bond. This can lead to the loss of a part of the invested capital or even to a total loss.
- **Barrier event:** In the case of Reverse Convertible Bonds with a barrier, touching or undercutting below the price threshold during the term invalidates the protection mechanism. How the certificate works

The annual fixed interest rate is paid out regardless of the underlying performance.

On the initial valuation date, the starting value of the underlying is determined and the barrier is defined. One of the following scenarios occurs on the final valuation date:

1. Share quotes above its barrier

If the final value of the underlying quotes above the barrier, 100% of the nominal value is paid out at the maturity date. This also corresponds to the maximum redemption.

2. Share quotes at or below its barrier

If the final value of the underlying quotes at or below the barrier, delivery of shares is affected.

In any case, the yield is limited to the amount of the fixed interest payments; investors do not participate in price increases of the underlying above its starting value.
