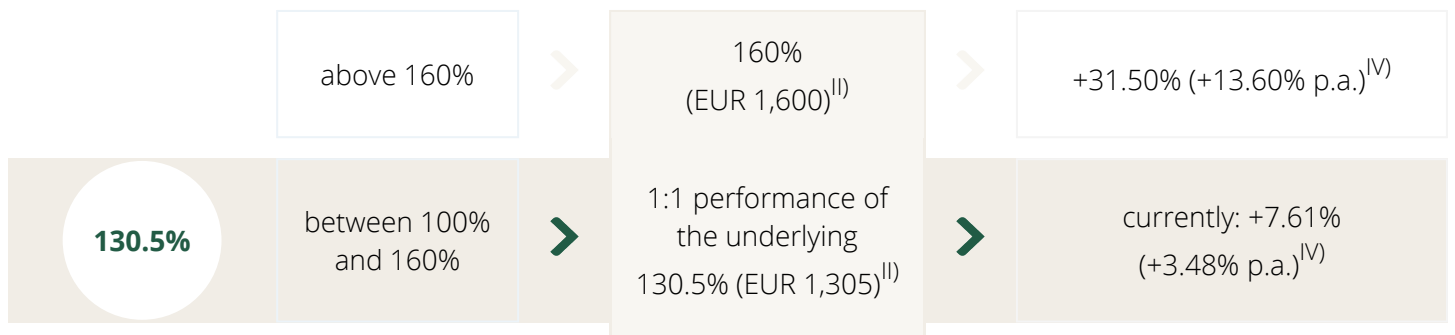

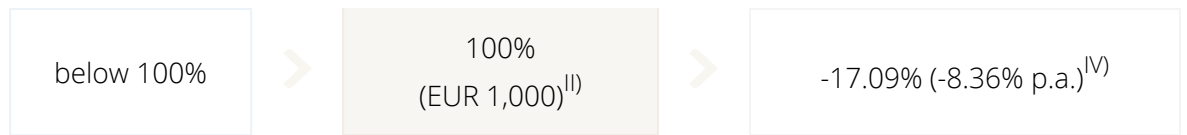

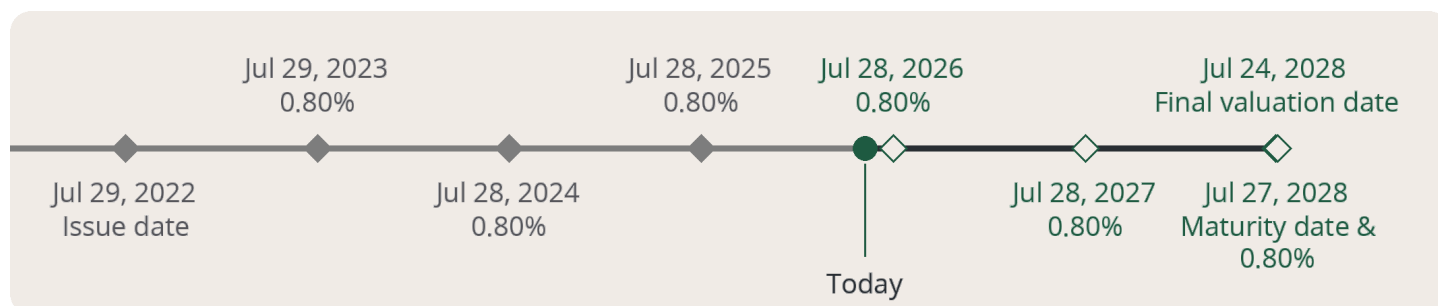

The Certificate

FUNCTIONALITY

At the **initial valuation date** the **starting value** of the underlying and at the **final valuation date** the **final value** are determined. At the final valuation date the final value is compared to the starting value and one of the following **scenarios** will apply:

1) Final value ≥ 160% of the starting value → Redemption at 160%

If the final value is greater or equal to 160% of the starting value, the certificate will be redeemed on the maturity date at 160% of the nominal value. This also represents the maximum redemption (maximum amount).

2) Final value ≥ 100% & < 160% of the starting value → 100% Participation

If the final value is greater or equal to 100% but less than 160% of the starting value, the certificate will be redeemed on the maturity date according to the performance of the underlying (percentage development from the starting value to the final value).

3) Final value < 100% of the starting value → Redemption at 100%

If the final value is less than 100% of the starting value, the certificate will be redeemed at 100% of the nominal value (capital protection) on the maturity date.

The **fixed interest rate** is paid out **in any case**, regardless of the underlying performance.

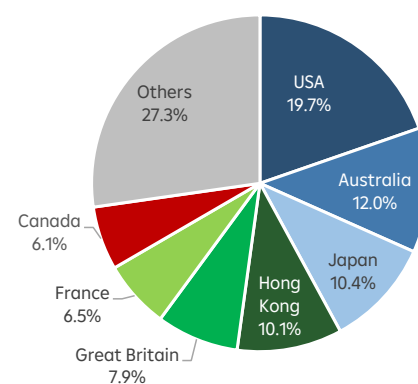
