Repayment at the end of the term

The repayment at the end of the term depends on whether the barrier has been breached or not. This results in two possible scenarios:

Scenario 1: Barrier not breached until expiry

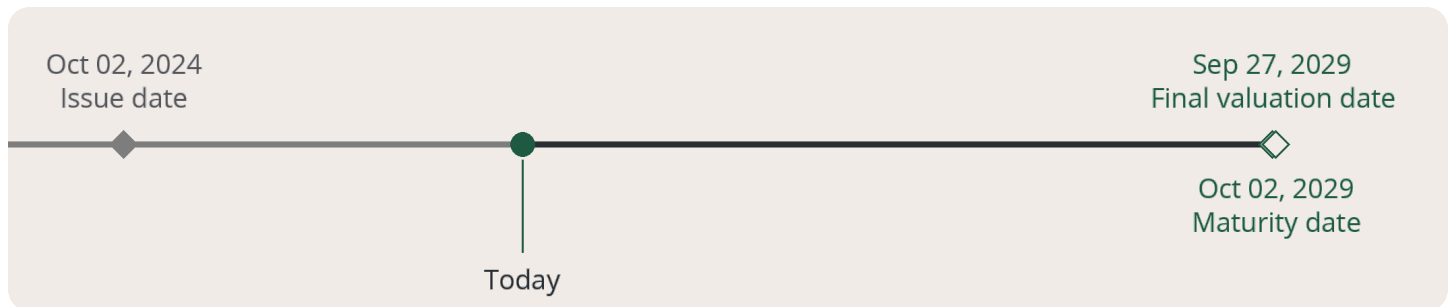

How the certificate works

At the initial valuation date the starting value of the underlying is fixed and from that the barrier is determined. During the observation period the underlying price is compared with the barrier.

- Barrier was touched or undercut at least once
In this case redemption on the maturity date will be affected according to the underlying performance. The maximum redemption remains capped at 128% of the nominal value amount.
