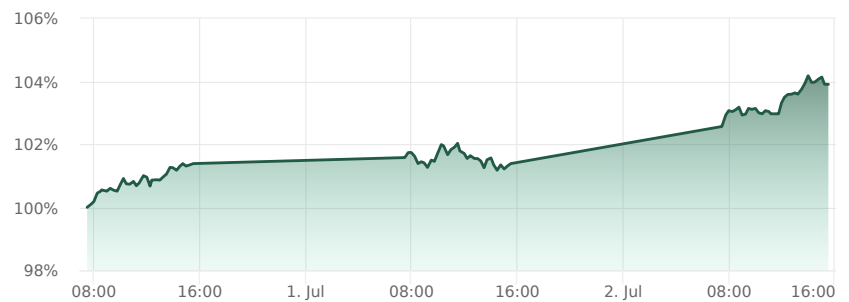

## Description

The certificate **OMV Express 20** refers to the OMV share, offers an annual yield opportunity of 10.5% and an early redemption option. If the share quotes at/above the starting value on one of the annual valuation dates, early redemption is made including interest of 10.5% per year to maturity. If it quotes below the barrier of 60 %, shares are delivered. The value of the shares delivered will be significantly lower than the nominal amount of the certificate.

The payout profile is already fixed when the certificate is issued. It is suitable for investors who expect the share to move sideways/slightly upwards. This certificate complies with the **sustainability standard for Raiffeisen Certificates** and takes into account important adverse impacts on sustainability factors ("PAIs").

## How the certificate works

On the initial valuation date the starting value of the underlying is fixed and the barrier is determined. On the annual valuation date, the price of the underlying is compared to the starting value. If the underlying is at or above the starting value, the certificate is redeemed (early) at the defined termination price. The maximum possible redemption is limited by the maximum amount.

**Share delivery**

If there has been no early redemption by the final year of term and the underlying price is also below the starting value on the final valuation date, the barrier is observed: If the underlying price is above the barrier, redemption is at 100% of the nominal value. If the underlying price is at or below the barrier, you will receive shares in your securities account.

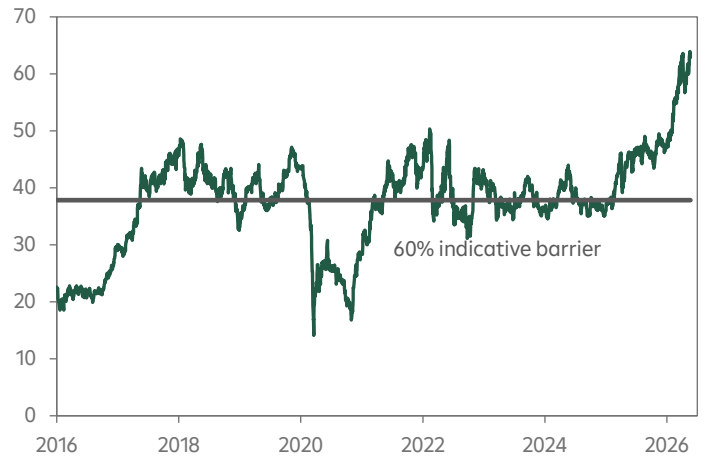
