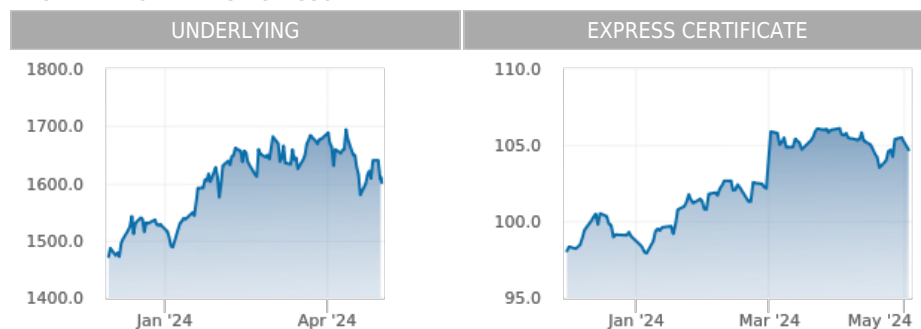

## DESCRIPTION
