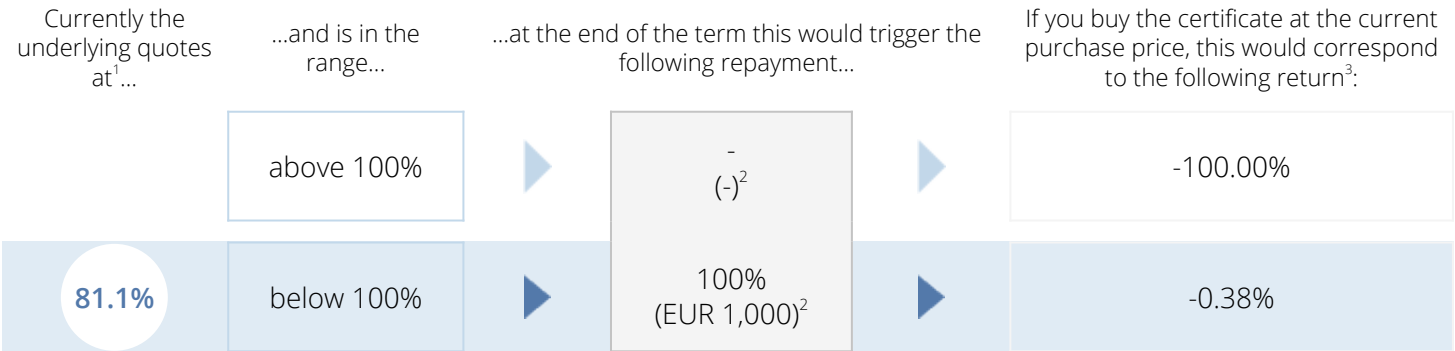

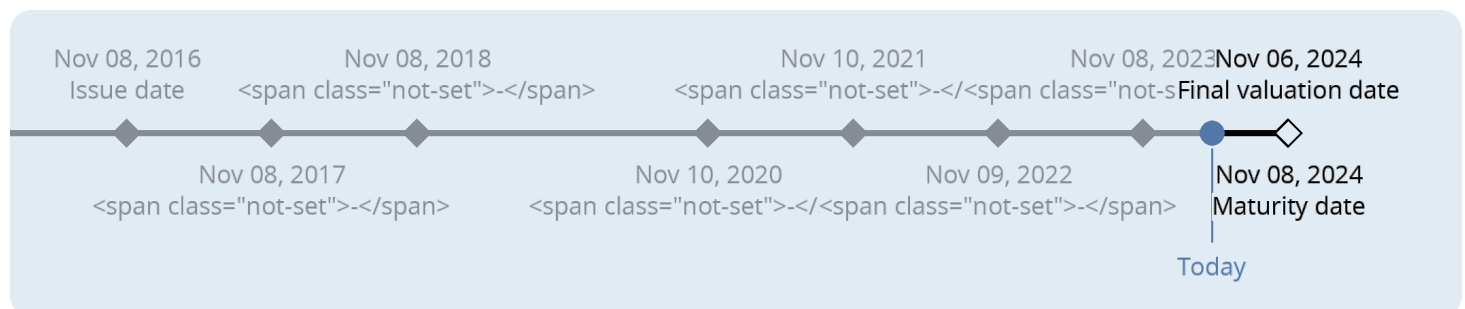

## The Certificate

The Guarantee Certificate Austrian Stocks Bond 2 provides investors with the opportunity to obtain an annual interest rate of 3.25%. The interest amount is paid, if all underlying shares (Andritz AG, OMV AG, voestalpine AG) quote above their respective starting value (=closing price at the initial valuation date) at the respective annual valuation date. The certificate will be redeemed at 100% of the nominal value at the end of the term (November 2024).

Please note:

- 100% of the nominal amount will in any case be paid out at maturity; during the term, the price may fall below the issue price or the capital protection level.
