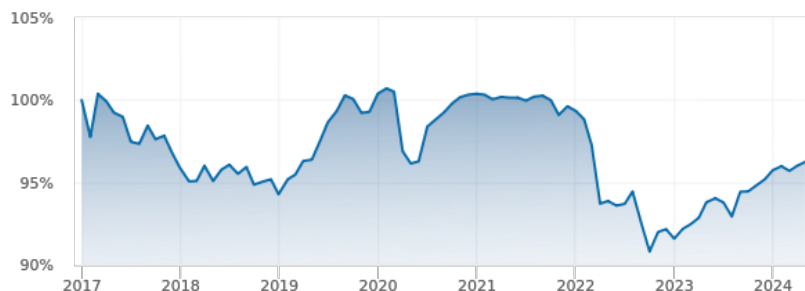

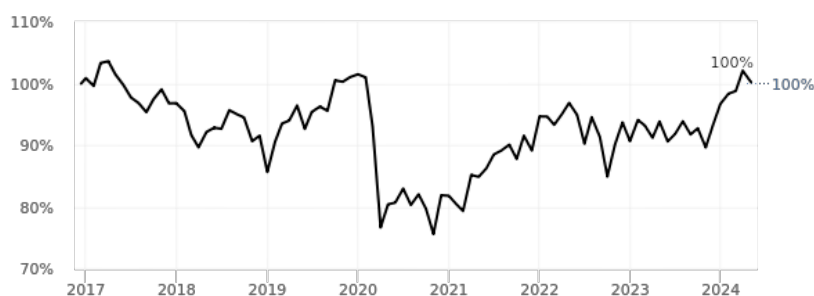

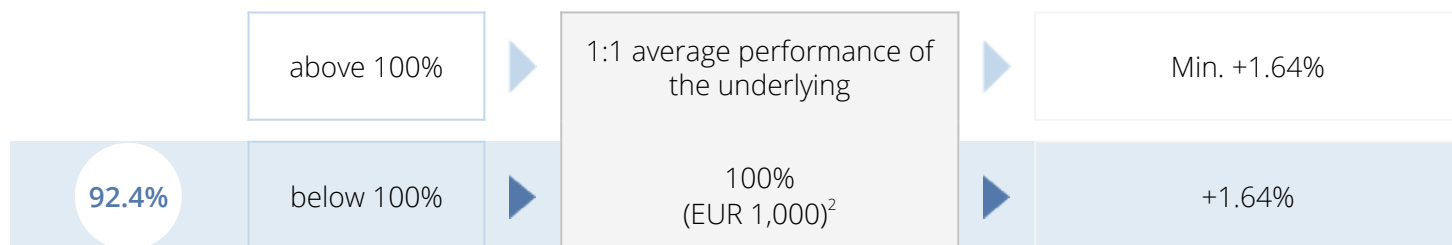

## The Underlying

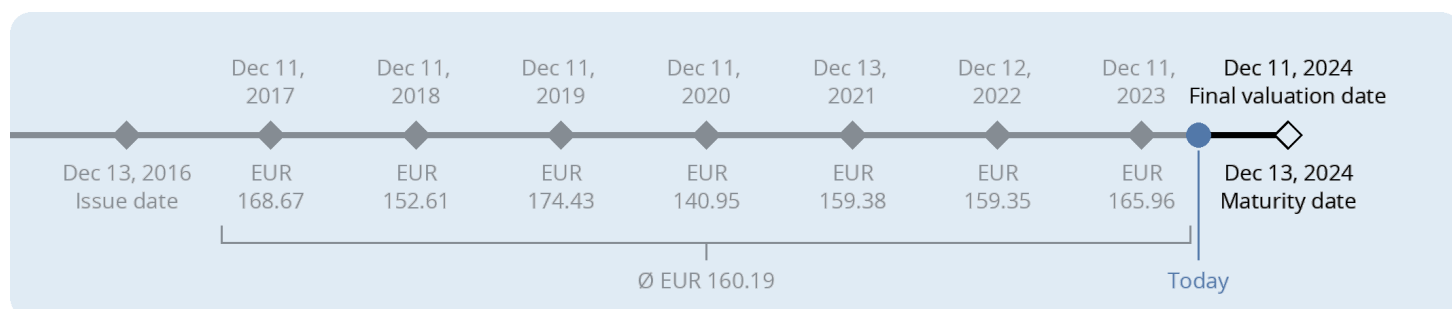
The iSTOXX® Global ESG Select 100 Index tracks the performance of 100 global companies that are among the best in the environmental, social and governance fields.
