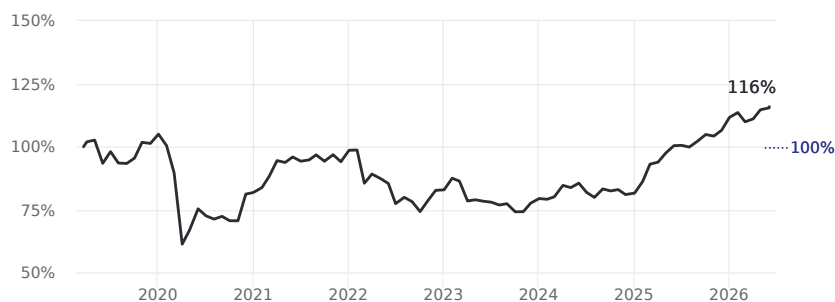

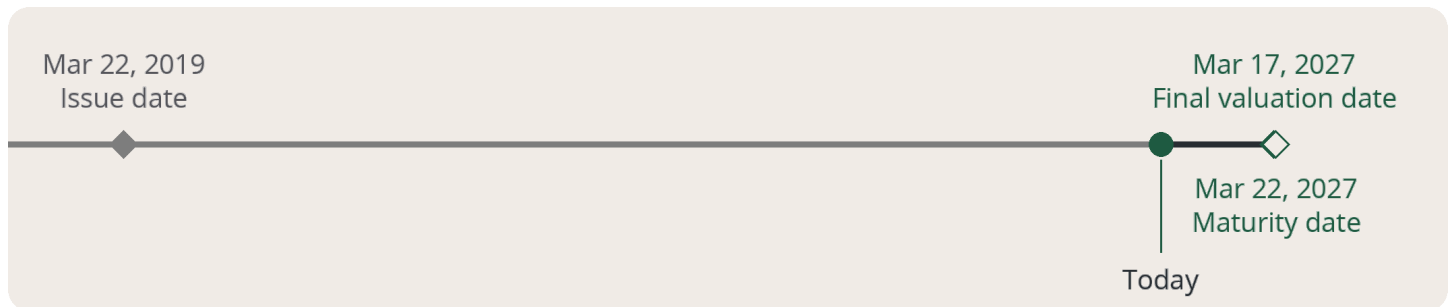

### The Certificate
