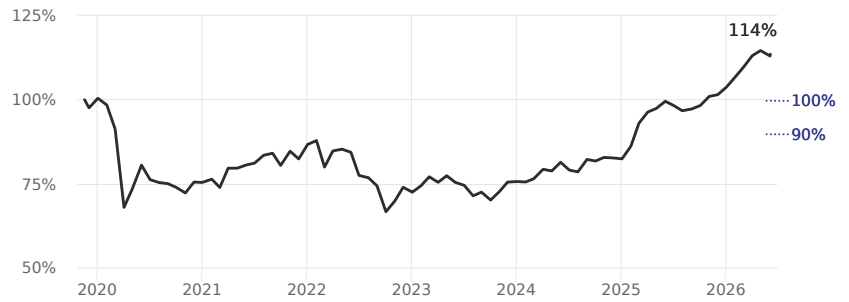

### The Certificate

With this certificate, investors receive a return of 40% if the price of the underlying STOXX® Europe ESG Leaders Select 30 Index quotes at or above 100% of its starting value at the end of the term (November 2027). In case of index reductions of up to -10%, redemption will be 100% of the nominal amount. With negative price developments of more than -10%, the capital protection of 90% at the end of the term.
