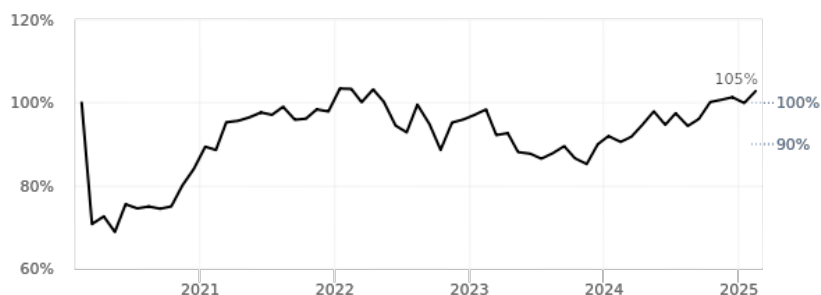

The Certificate
