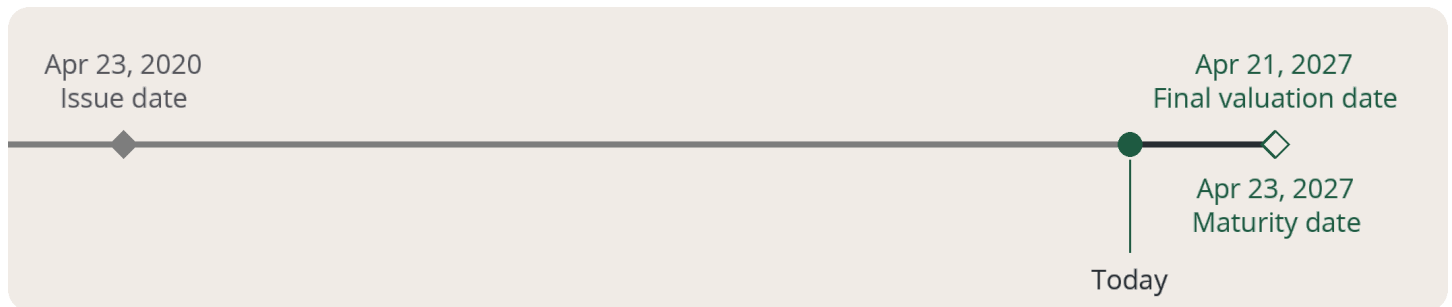
The Certificate
