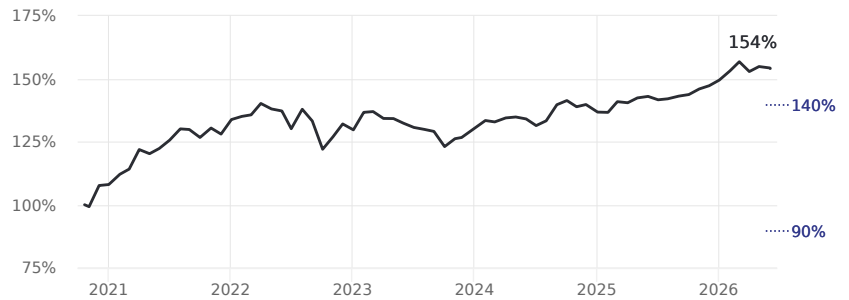

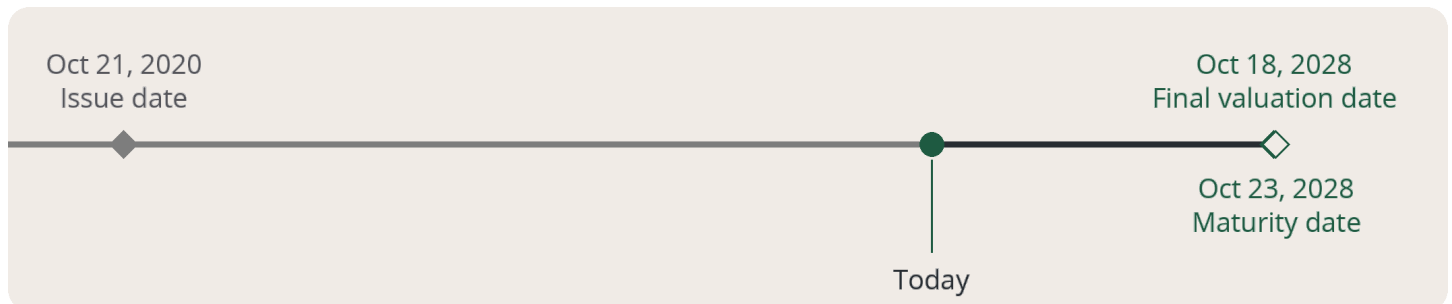

### The Certificate

With the Ethics Winner 90% certificate investors participate at 100% in the positive performance of the iSTOXX<sup>®</sup> Global Ethical Select 30 index at the end of the term up to a maximum of +40% in relation to the starting value.
