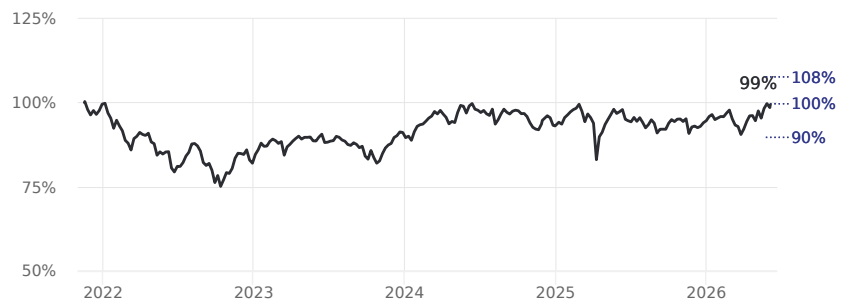

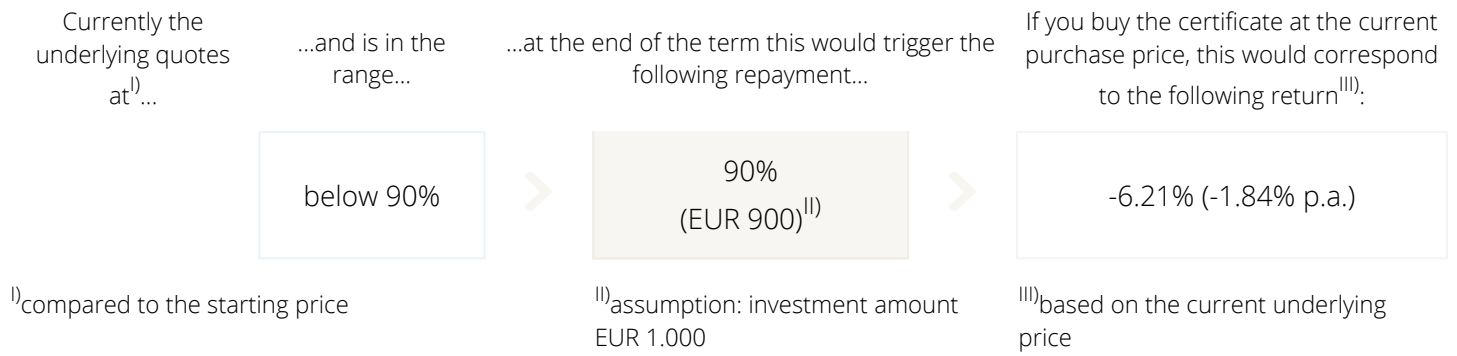

### The Certificate

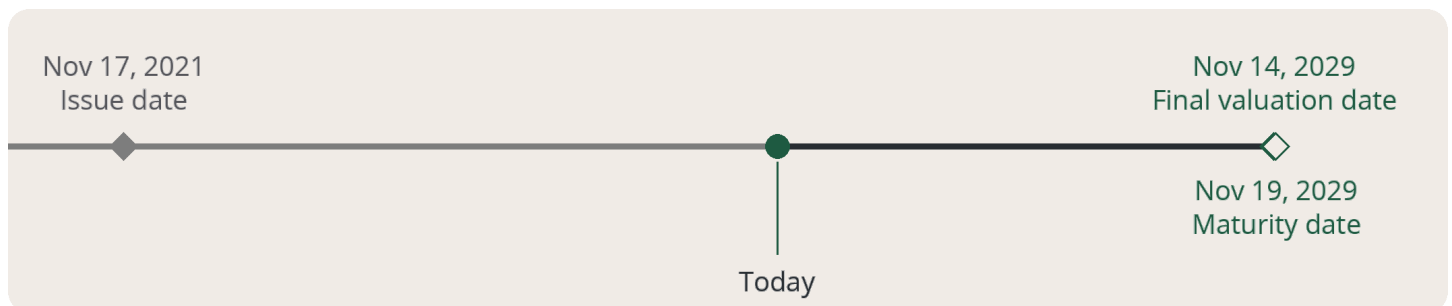
With the certificate MSCI Europe Sustainability Bond 90% II, investors achieve a return of 26% if the price of the MSCI<sup>®</sup> Europe TOP ESG Select 4.5% Decrement Index quotes at/ above 108% of the starting value at the end of the term. If the index quotes below 108% but at/above 100% of the starting value at the end of the term, redemption is effected at 108% of the nominal value. If the index declines by up to -10%, the redemption is effected at 100% of the nominal value. In case of a negative price performance of more than -10%, the 90% capital protection applies at the end of the term.
