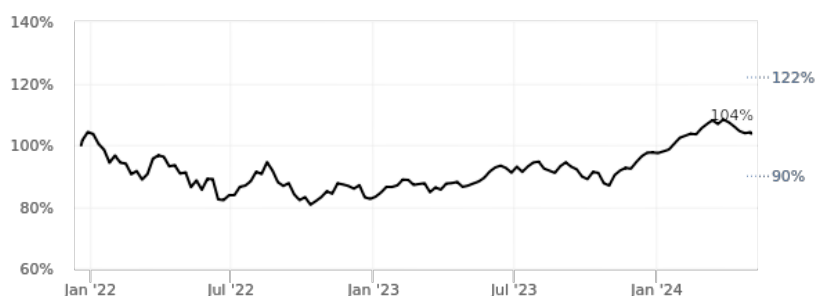

### Price underlying (% of the starting value)

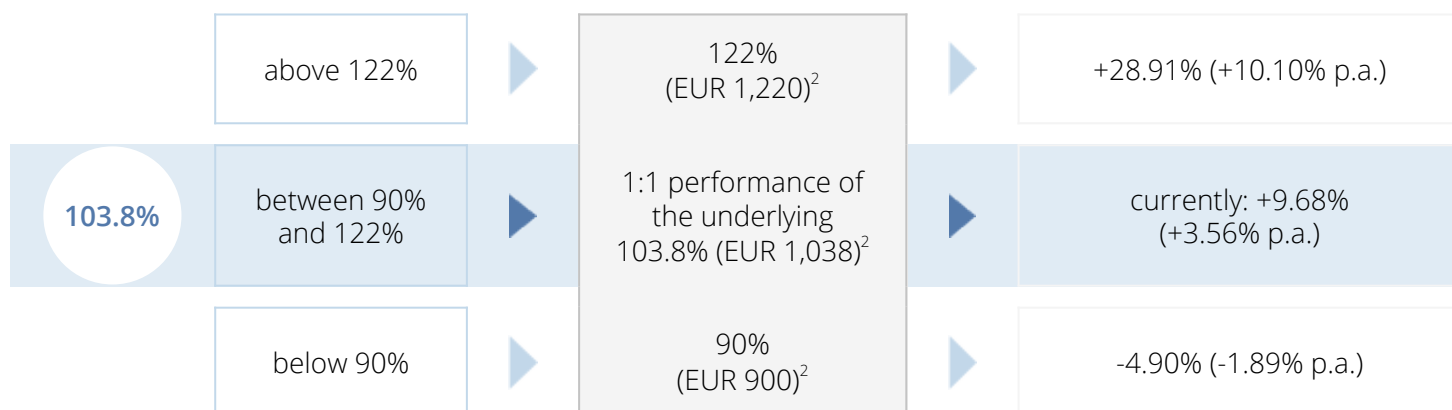

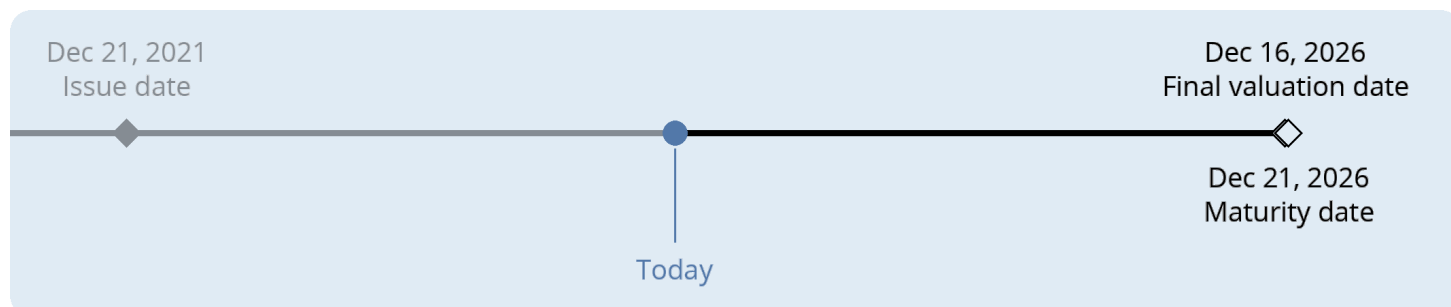
**Best in class:** Only shares of the top 50% companies with the highest sustainability rating (ESG) calculated by MSCI in the respective sector are taken into account.
