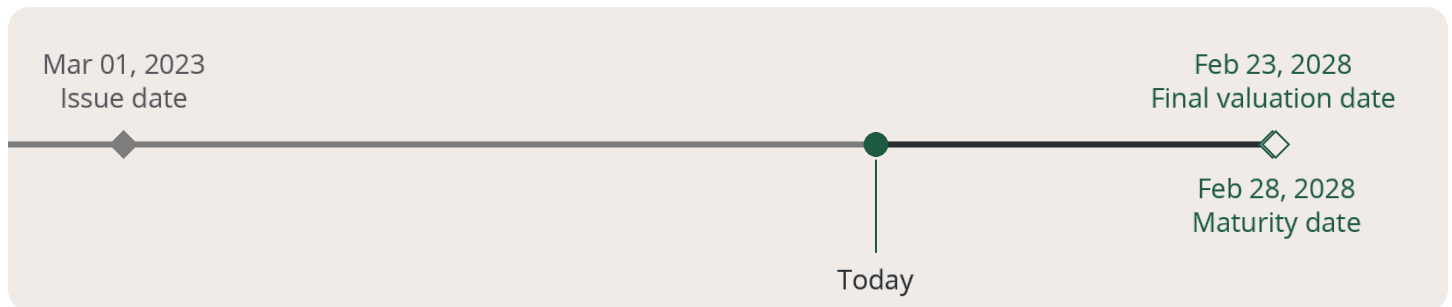

### The Certificate

The certificate Dividend Stocks Bond 7 has two redemption scenarios: 1) Redemption at 137% if the underlying STOXX® Global Select Dividend 100 Price EUR index is at/above 100% of the starting value at the end of the term; 2) 100% Capital protection if the index is below 100% of the starting value at the end of the term (February 2028).
