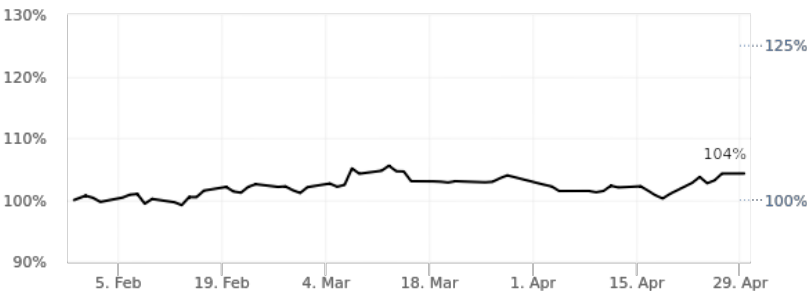

Price underlying (% of the starting value)



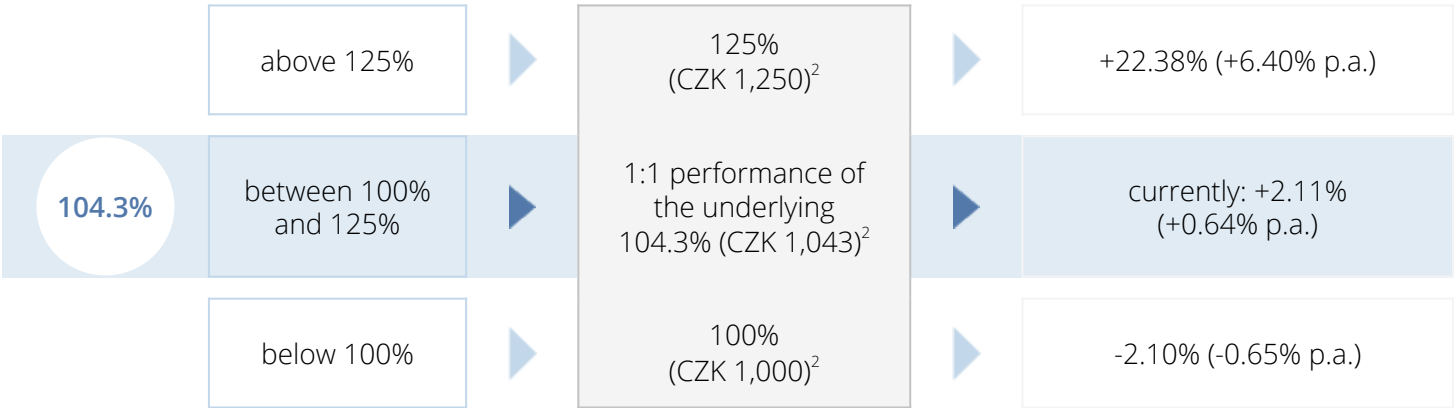

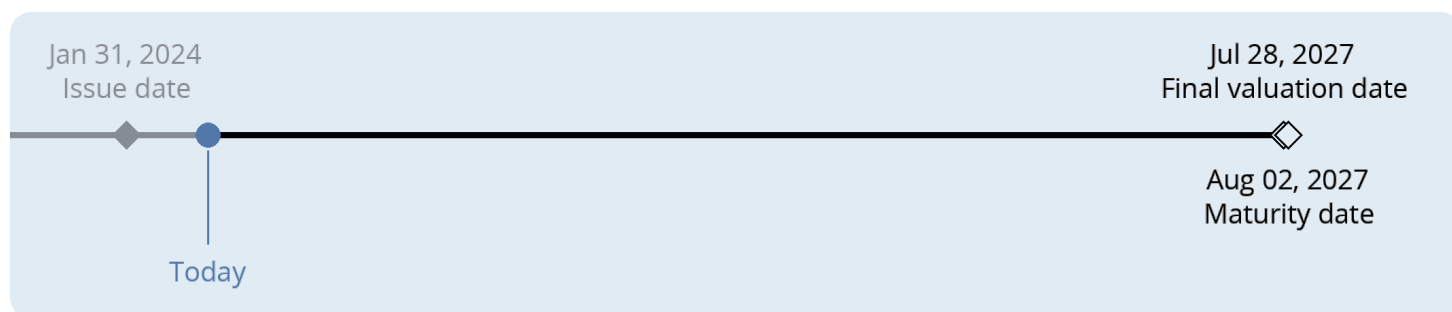
### The Certificate
