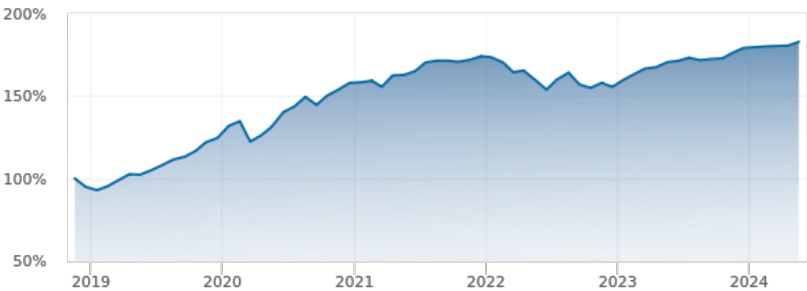

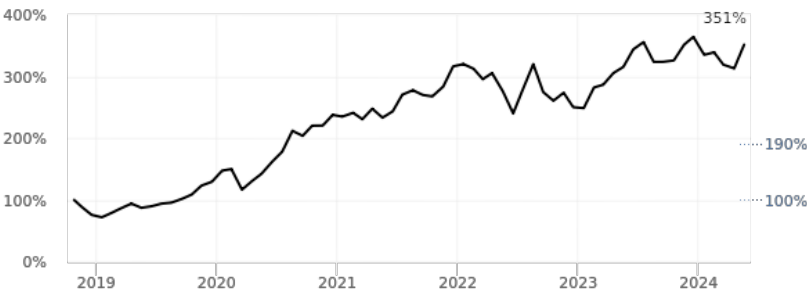

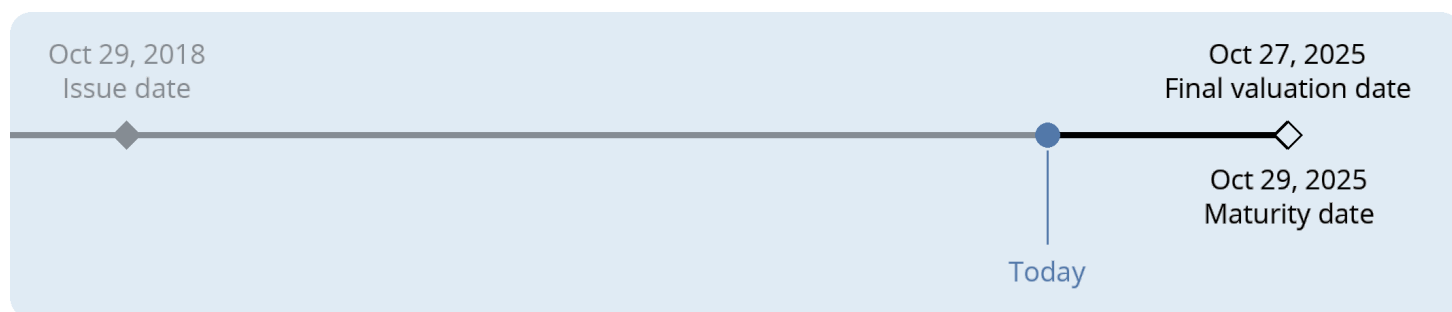
The Certificate

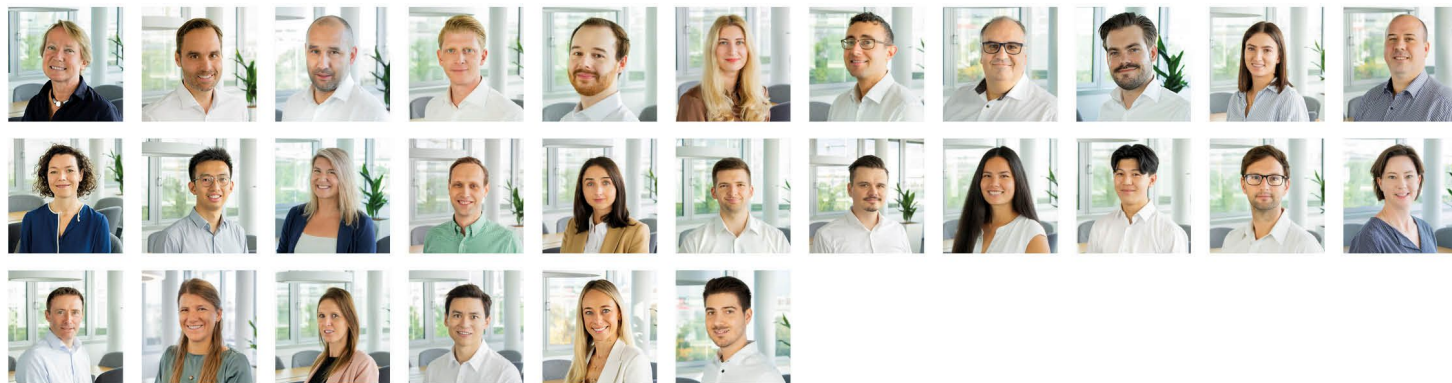
