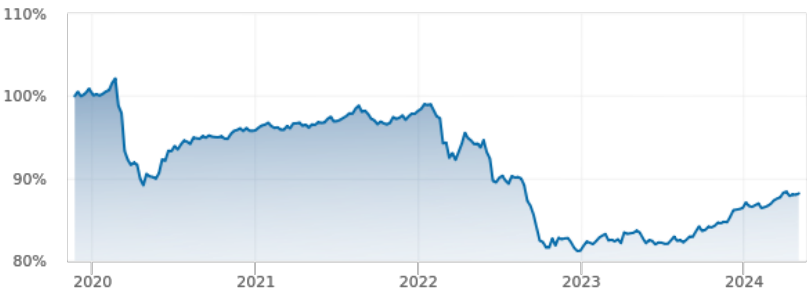

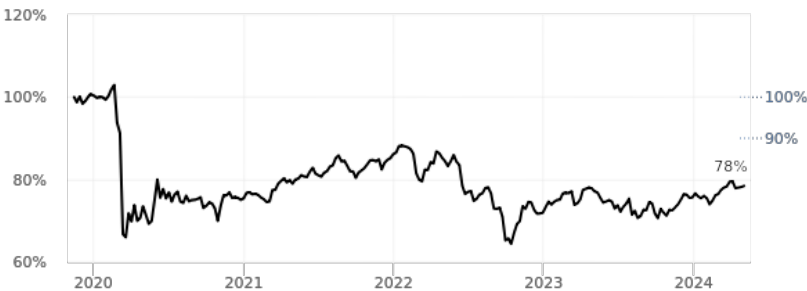

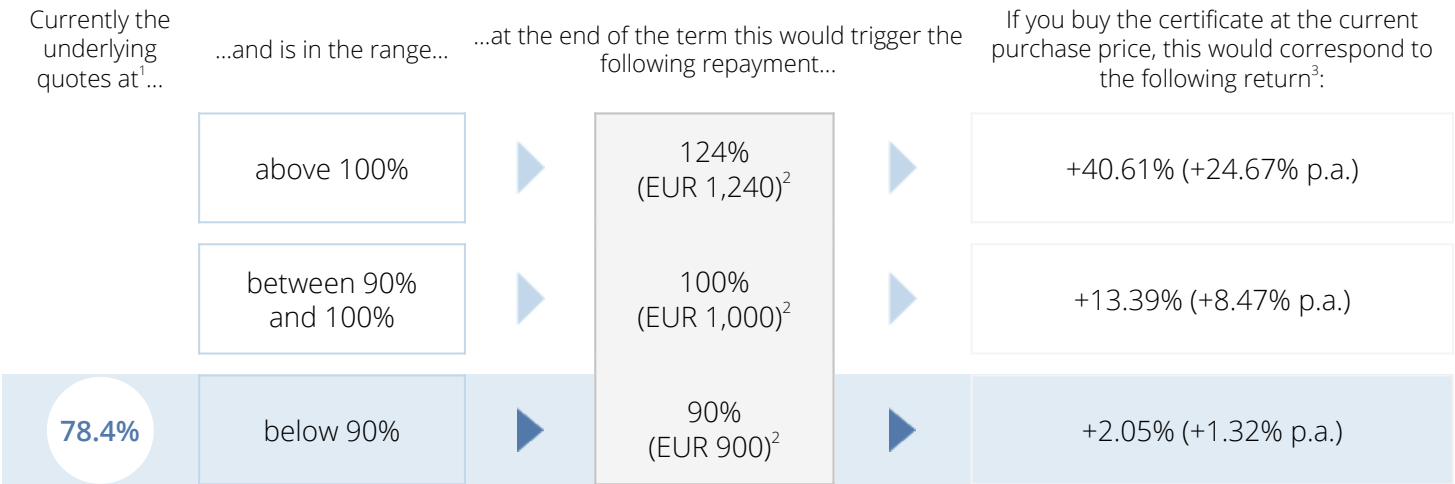


Price underlying (% of the starting value)

Select: Stocks with low volatility and high dividend yields are selected.
