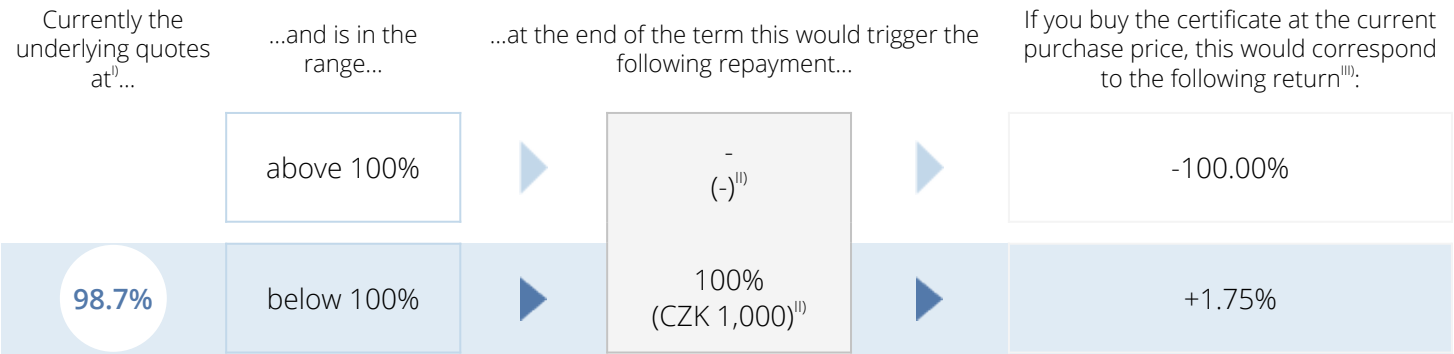

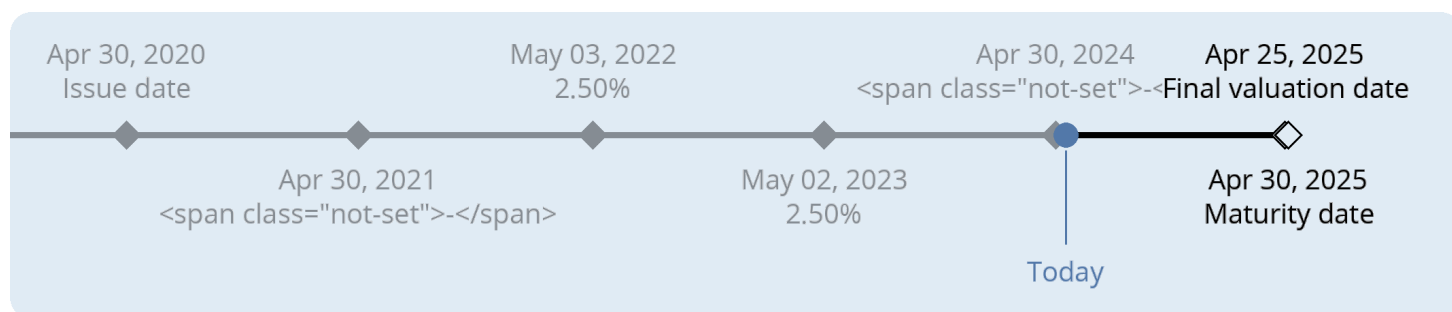
The Certificate
