### The Underlying

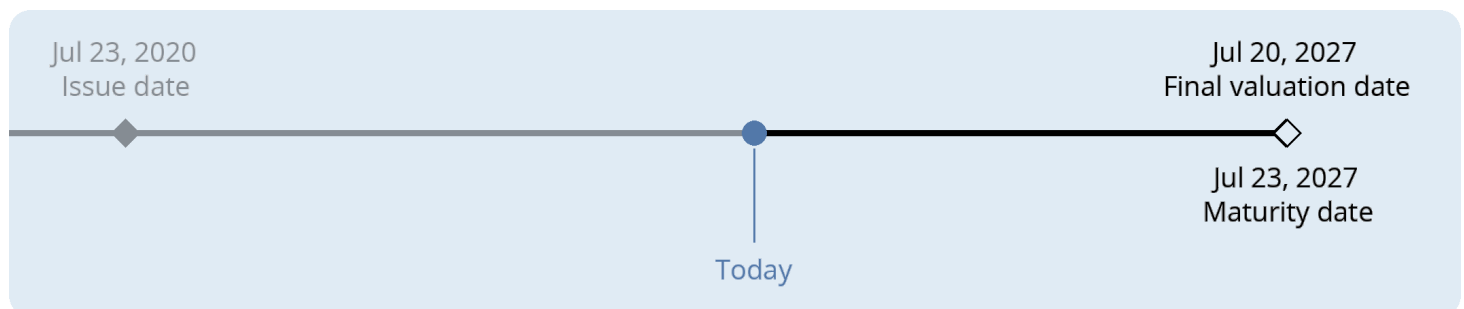
