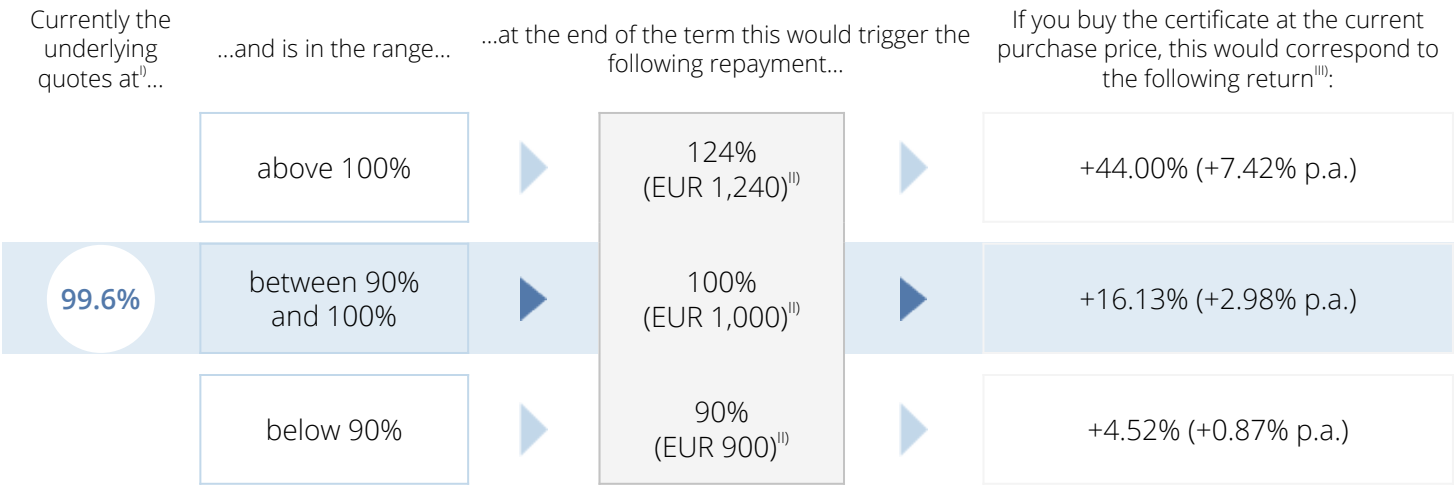

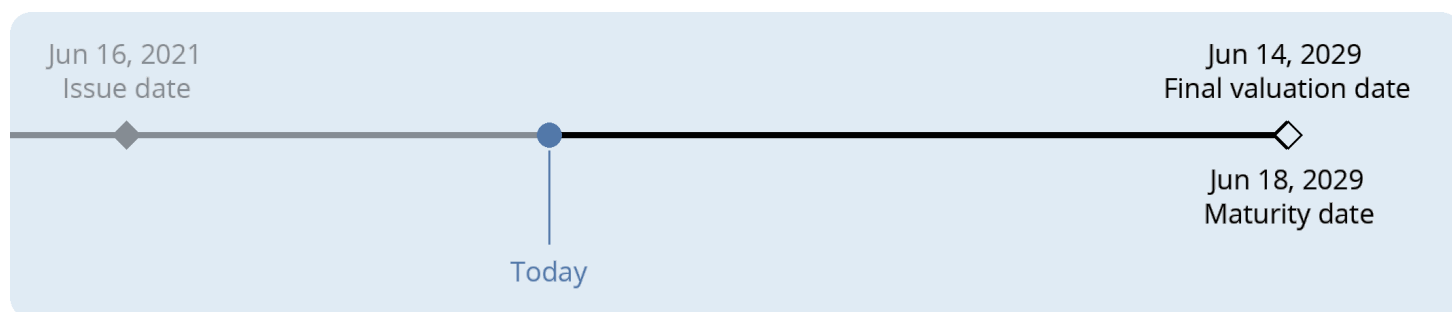
The Certificate
