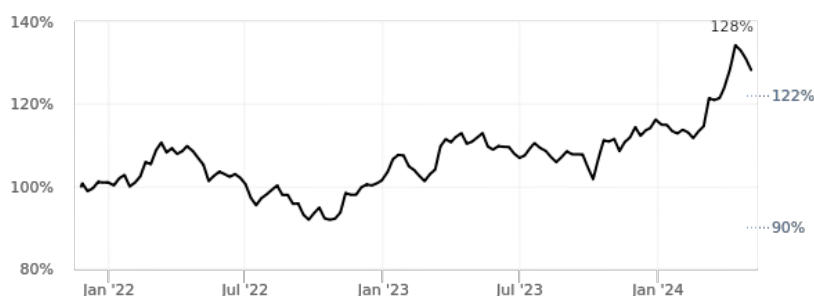

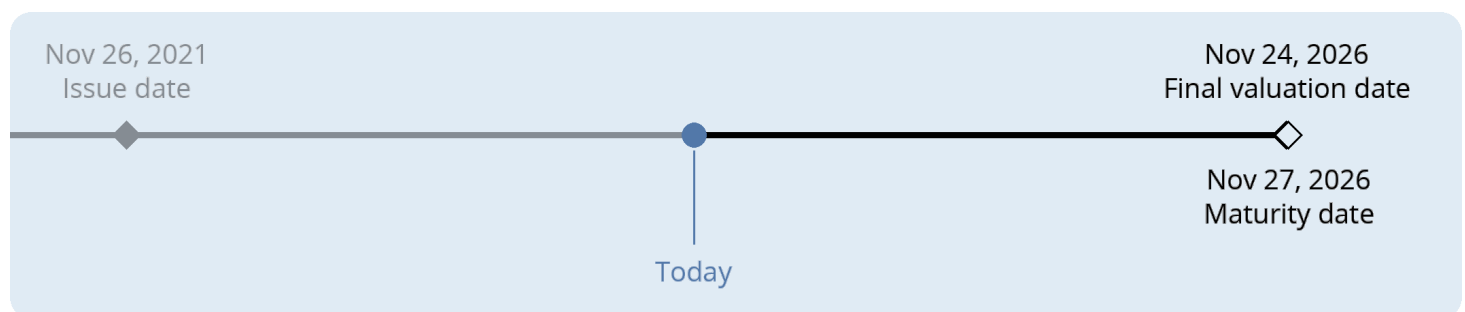

### The Certificate

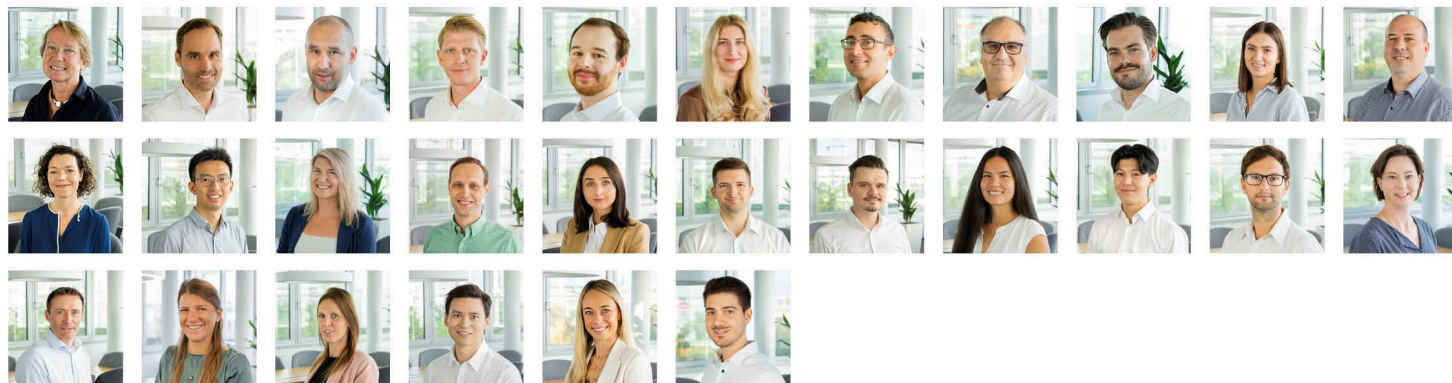
