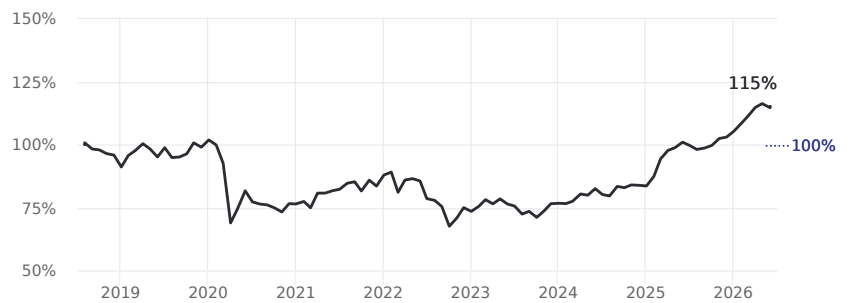

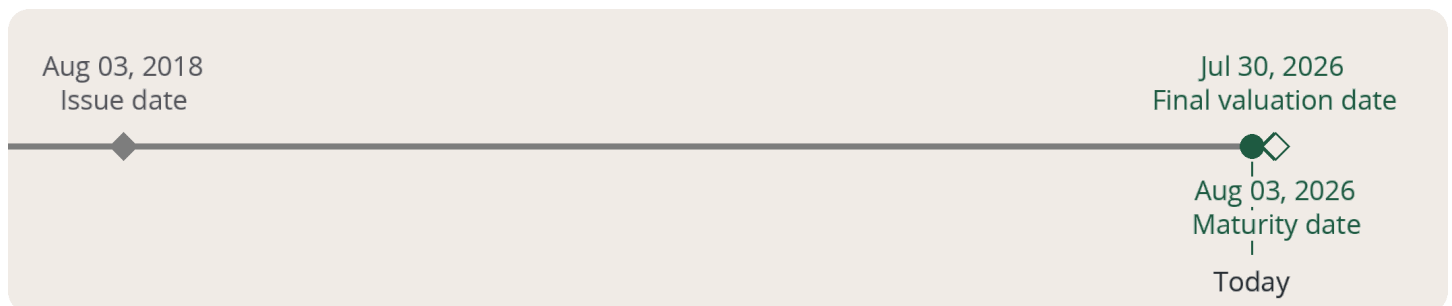

### The Certificate

With this Certificate investors obtain - based on the issue price - a yield of 32% at the end of the term, provided that the STOXX® Europe ESG Leaders Select 30 Index index quotes at or above the starting value at the end of the term. In this case this Certificate will be redeemed at EUR 1,320.00 per nominal value (maximum amount). In case the STOXX® Europe ESG Leaders Select 30 Index index quotes below the starting value at the end of the term, redemption at the maturity date will be effected at 100% of the nominal value (capital protection).
