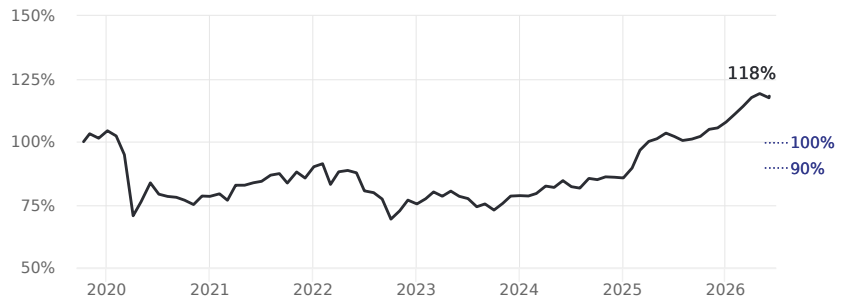

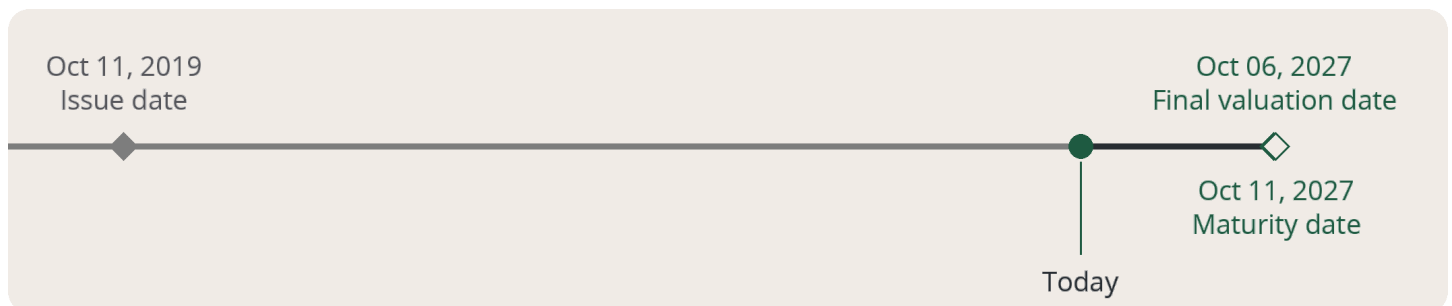

### The Certificate

With this certificate, investors receive a return of 40% if the price of the underlying STOXX® Europe ESG Leaders Select 30 Index quotes at or above 100% of its starting value at the end of the term (October 2027).
