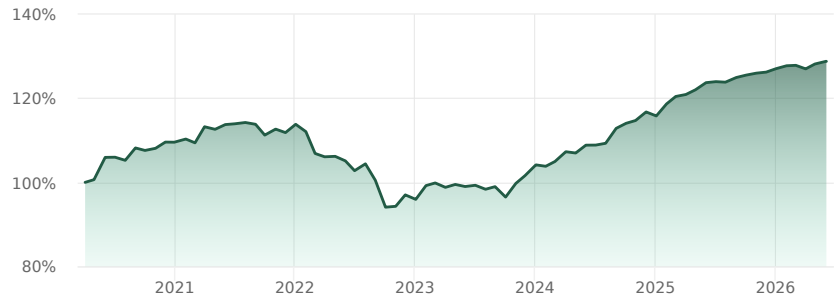

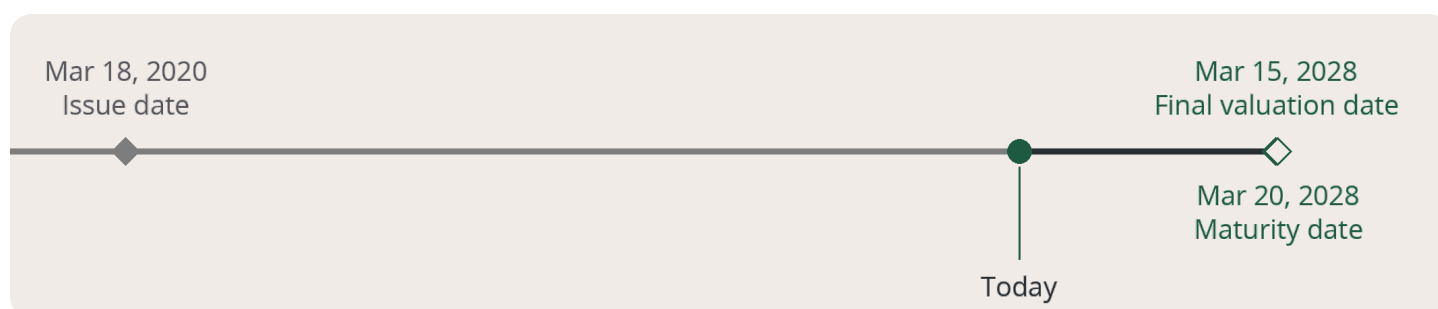
The Certificate

With the certificate, investors receive a return of 40% if the price of the underlying STOXX® Global ESG Leaders Select 50 index quotes at or above 100% of its starting value at the end of the term (March 2028). In case of index reductions of up to -10% at the end of the term, redemption will be effected at 100% of the nominal amount. With negative price developments of more than -10%, the capital protection of 90% at the end of the term.

NOTE: The product brochures for download already contain the current underlying price from March 9th, 2020.
