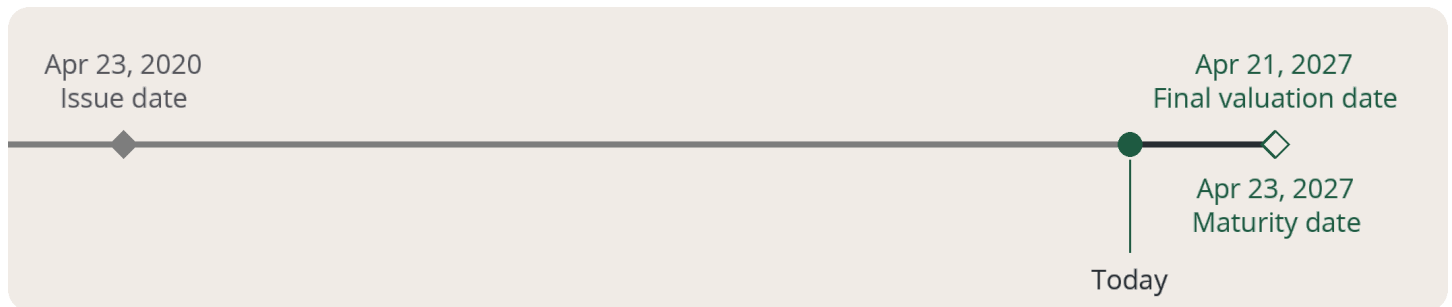
The Certificate
