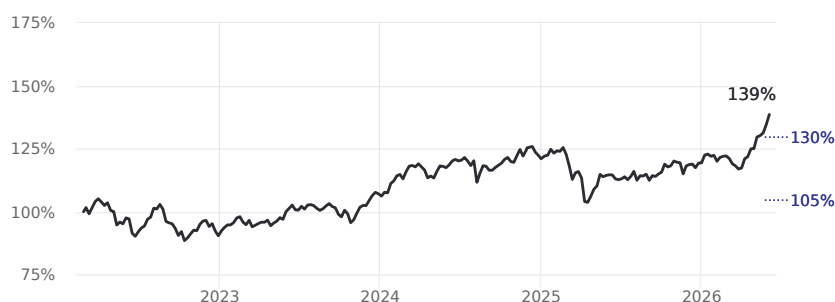

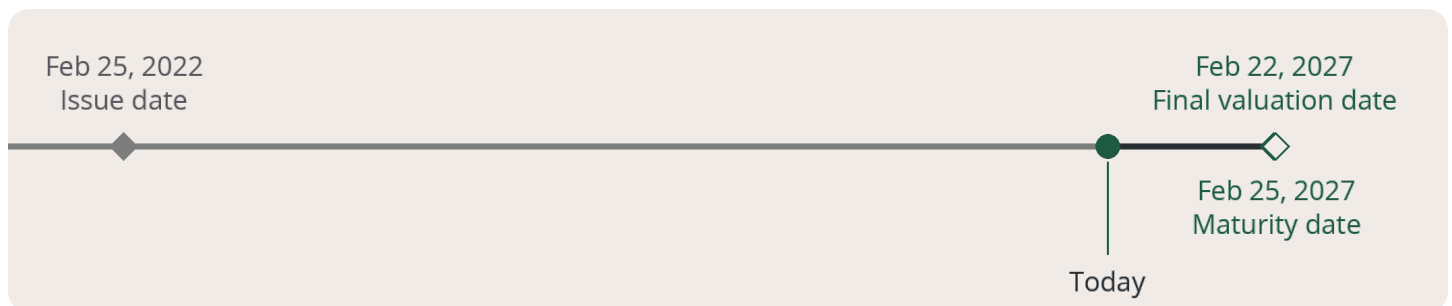
The Certificate
