#### Price certificate (% of the starting value)

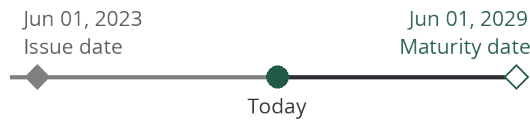


#### Price underlying (% of the starting value)

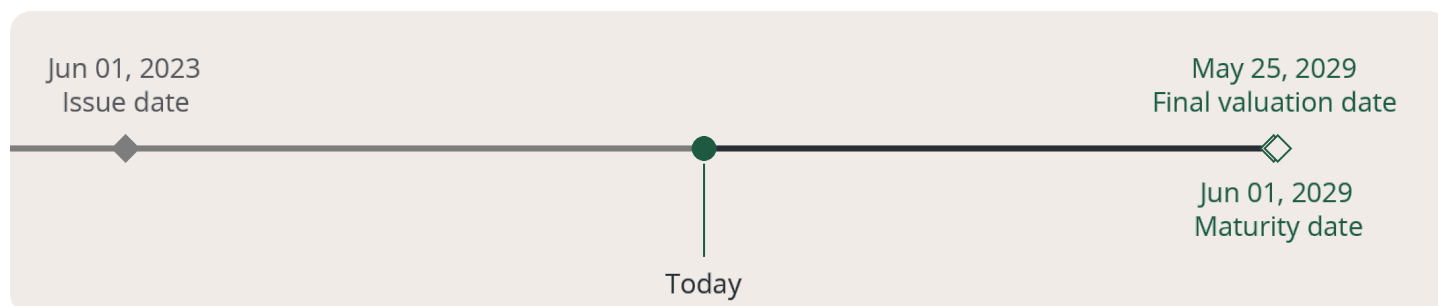

### The Certificate

The certificate Dividend Stocks Bond 10 has two redemption scenarios: 1) Redemption at 153% if the underlying STOXX<sup>®</sup> Global Select Dividend 100 Price EUR index is at/above 100% of the starting value at the end of the term; 2) 100% Capital protection if the index is below 100% of the starting value at the end of the term (June 2029).

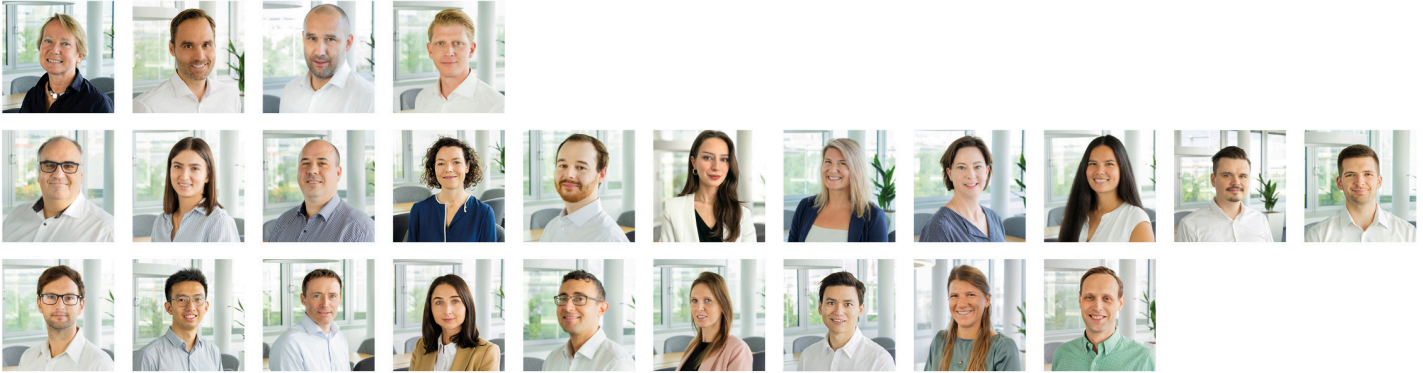
