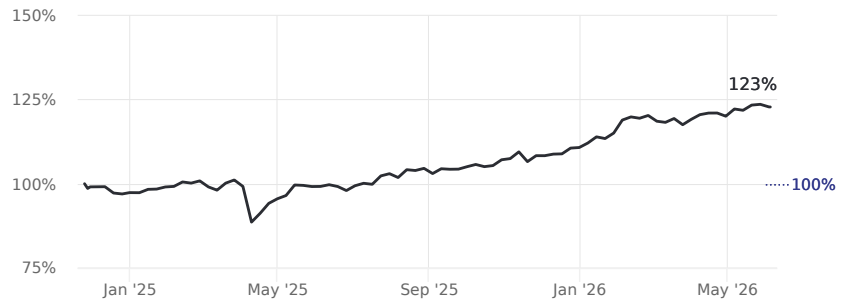

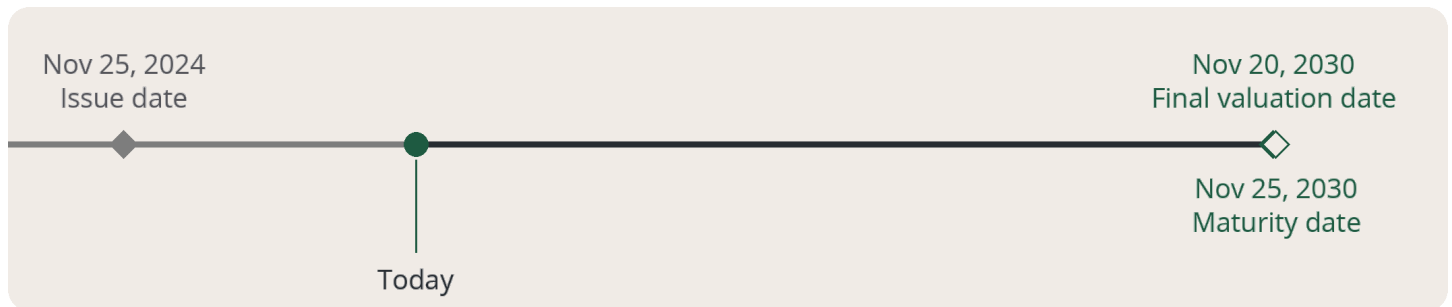

### The Certificate

For this certificate Dividend Stocks Bond 12 there are 2 possible redemption options, depending on the price of the underlying at the end of the term: 1. underlying at or above the starting value: redemption of 138% 2. underlying below the starting value: 100% capital protection at maturity (November 2030)
