## Repayment at the end of the term

The repayment at the end of the term depends on whether the barrier has been breached or not. This results in two possible scenarios:

### Scenario 1: Barrier not breached until expiry

**Current scenario, as the barrier has not been breached.**

During the term: Fixed interest payments	4 x 4% p.a.

### Scenario 2: Barrier violated at least once

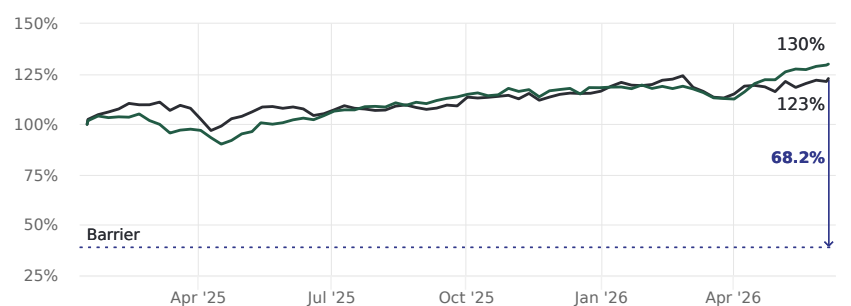
During the term: Fixed interest payments	4 x 4% p.a.

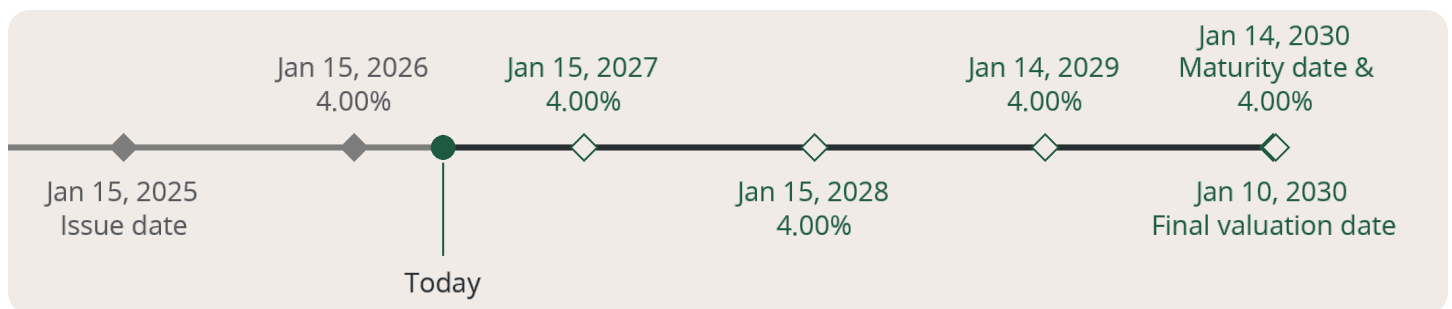
