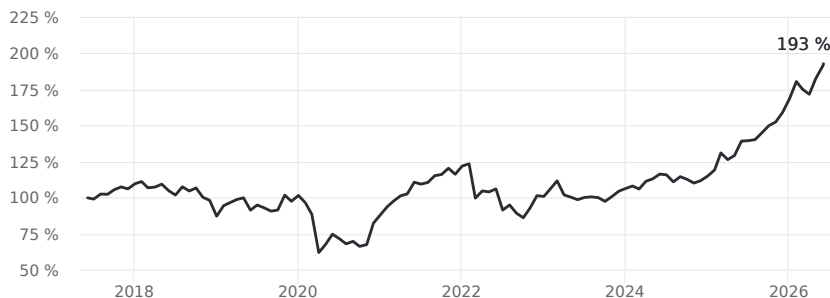
Opis
